Working with our partners, LADCO exists to actively facilitate and promote economic development and business retention in La Crosse County. This facilitation and promotion are accomplished by focusing on:

- · Retaining and expanding existing businesses--LADCO actively builds relationships with local businesses and key stakeholders.
- Attracting new industry--LADCO works closely with developers and site selectors.

To help realize these projects, LADCO worked as a facilitator and matchmaker to connect the businesses with possible real estate solutions and brokers, available financial tools and resources, and with the local governments and Wisconsin Economic Development Corporation (WEDC). LADCO provided technical assistance on real estate, financing and incentive programs, and gathered and communicated critical information to help these developments move forward. These projects, and more, generated millions of dollars in new construction and economic activity, retained and created new jobs and housing, and made significant investments in each community.

ADDITIONAL SUCCESSES INCLUDE:

Technical and financial support of startup businesses like CompRex, LLC, α developer and manufacturer of compact heat exchangers located in the Coulee Region Business Center (CRBC). LADCO helped secure space in the CRBC, and lowcost financing for new equipment.

Advocacy for the La Crosse Regional Airport, helping them to secure a small community air service development grant from the Federal government to add flights to Detroit. With Delta's recent announcement to discontinue service at La Crosse Regional Airport (LSE), LADCO is leading the local effort to secure an alternative airline to fly in and out LSE.


